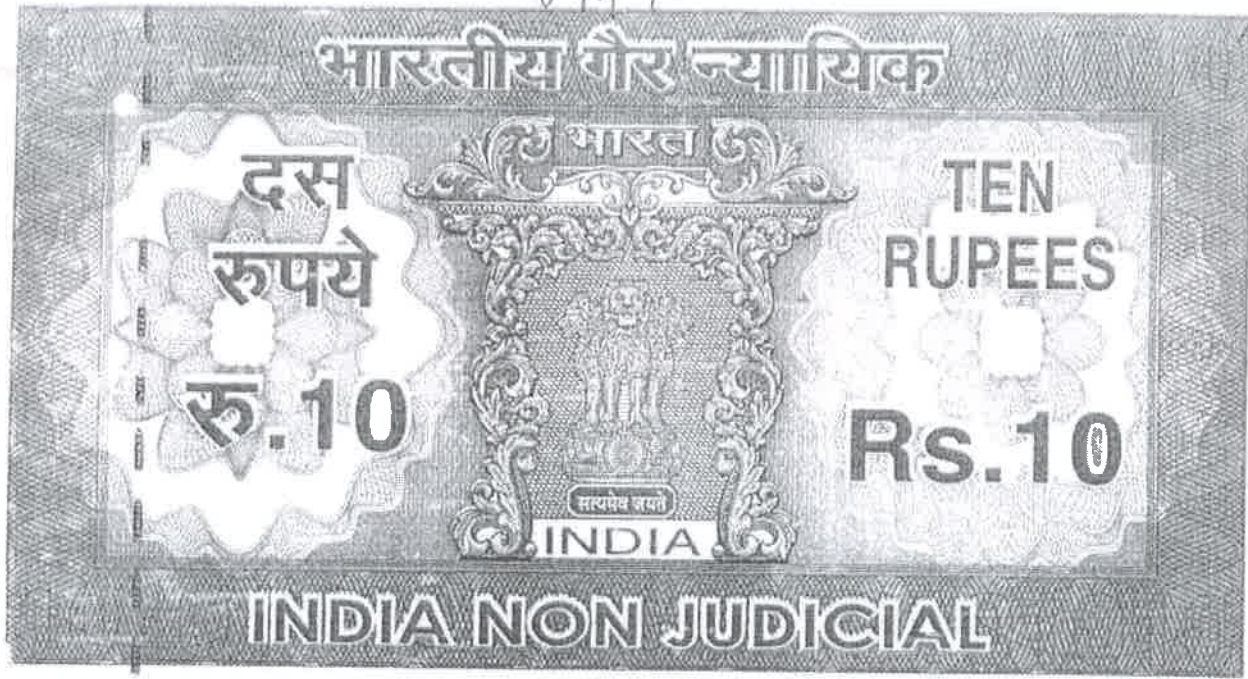

1 NAME: The name of the society hereafter shall be known as  
KENNEDY GLOBAL SCHOOLS EDUCATIONAL SOCIETY.

2 LOCATION: The office of the society shall be located at Dr.No: 9-208, M.G. Road, Siri Nagar, Vijayawada-520 007, Krishna District, Andhra Pradesh.

3 JURISDICTION: The Jurisdiction of society shall extend to the whole of Andhra Pradesh.

4 MEMBERSHIP:

[a] Any Indian Citizen who is 18 years old is eligible for the membership of society. The membership may be extended on the terms and conditions laid down by the Executive Committee from time to time

[b] Every member pays Rs.250/- as the annual subscription at the beginning of every academic year. If the subscription is not paid within one month of the commencement of the academic year, the member shall forfeit the membership without any notice and such member will not have right to exercise his vote.

[c] All persons who donate Rs. 10,000/- will be considered as Patron members of the society. They have also to pay the annual subscription as usual to continue their membership.

[d] Managing Committee shall have the right to remove any member/s for activities prejudicial to the objectives of the society after giving such member an opportunity to show cause against such removal.

Withdrawal or removal of membership:

[e] A member may withdraw from the society by intimating the fact in writing to the Secretary & Correspondent of the Society. He will not be entitled for the refund of any subscription or donation paid by him.

[f] A member may be removed from the membership of the society if he or she acts in any manner prejudicial to the interests of the society.

5 ANNUAL GENERAL BODY MEETING :

[a] There shall be an annual meeting of the society convened after 10 clear days notice. The notice shall contain the ~~time and place~~ of the annual meeting and also the purpose. - NE (Gates) Prasad.

[b] The annual meeting shall be in the month of May every year and in that meeting the annual report of the Managing Committee together with a statement of accounts, duly certified by a Chartered Accountant shall be presented and passed every year.

[c] The Managing Committee, inclusive of the office bearers, shall be elected by general body, for a period of three years.

[d] The general body shall appoint a Chartered Accountant of the society for the coming year.

6 FUNCTIONS :

Managing Committee: The exact number of Managing Committee including office bearers is; SEVEN

(A) President:

[i] She shall preside over the meetings of managing committee and generalbody . Any ruling given by her at such meetings shall be final

[ii] She shall have an overall control over the administration of the society.

(B) Secretary & Correspondent :

He shall be the Executive Officer of the society and perform the following duties:

i) All documents executed on behalf of the society shall be in the name of the Secretary & Correspondent.

ii) He shall sign all correspondent of the society.

iii) He shall issue notices and prepare the Agenda of the meetings of the Managing Committee and the General Body of the society.

iv) He shall prepare a monthly statement or receipts and expenditure of the cash and statements showing the equipment, articles, received, distributed and place them before the managing committee.

v) He shall be the person to issue any statement in the name of the society with the concurrence of the president.

vi) He shall appoint members of the establishment or fill in vacancies with the concurrence of the president and has also powers to retrench

vii) He has power to take disciplinary action against the staff or workers as to keepup the disipline and order of the society, - NE Prasad

viii) He shall have powers to correspond, negotiate or enter in to contract with Government Departments, Private Persons in our country or foreign countries in the interest of the Society.

ix) He shall arrange for the proper maintenance of accounts.

x) He shall be co-signee for all banking transactions.

He will act as Secretary and perform his duties during the absence of the Secretary.

**[D] Treasurer :**

i) He shall have custody of the funds and valuable documents of the society.

ii) He shall maintain accounts, receipts, vouchers, etc., as required for accounting the cash receipts and payments.

iii) He shall help the Secretary and Correspondent in preparation of all the financial statements.

**7 MEMBERS :**

The members shall be used for any type of executive work as directed by the Secretary & Correspondent.

**8 QUORUM :**

The quorum of the general body shall be 1/3rd and Managing Committee meetings shall be 2/3rds of the members. The resolutions of the generalbody/Managing Committee shall be passed if it is voted by a simple majority.

ii) All the funds of the society shall be deposited in a Bank as may be decided by the Managing Committee.

iii) The funds of the society shall be utilised for the benefit and improvement of the society and shall not be otherwise utilised.

iv) The funds or portions of it shall not be paid or transferred directly or indirectly to any of its members by any means.

v) The president shall be liable for any loss incurred.

**11 AMENDMENTS :**

i) No amendments or alteration shall be made unless it is voted 3/5th of the members present at a general body meeting convened for the purpose and confirm with 3/5th majority of the general body of the members present at a second special meeting.

ii) No amendments to add, alter or delete any rules and regulations of the society shall be made without the prior approval of the Commissioner of Incometax.

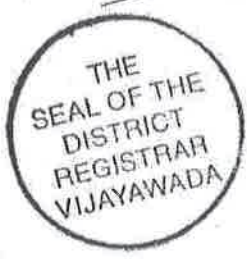
